Competitions

Registration for several competitions opened on 1st January and the number of entries is now building fairly rapidly

Issues/ request

On a number of occasions, I have received invoices to be paid which, for me, are unexpected. As an example, Champion of Champions event at Woodhall Spa – 2 days before Xmas I received a request from Ken Coffey for reimbursement for course guide and hotel for the event which took place at the beginning of September. Total amount claimed £247 – is full payment agreed?

It would be helpful if team captains could:

- Confirm the names of individuals in their respective squads
- The location/ dates of any practice matches/ games that as captains you have authorised so that I can pay travel claims
- Encourage team members to submit expenses claims within a reasonable time period i.e. within 1 month of the event

Budgets

Preliminary work on proposed budget for the current financial year is underway. I have received information for seniors but need some indication for 1st and 2nd teams and juniors. In the meantime, I have constructed a "break-even" budget as a reference point, with an approximate 10% uplift on income and expenditure. Some items have been removed from the budget as they are no longer relevant e.g. Blue Books
